#### **Global Objectives:**

- Discuss the unique barriers to mental health care in rural areas of the state and develop strategies for improving access to care for underserved populations.
- Identify signs of opioid use and demonstrate crisis intervention techniques for individuals experiencing or potentially experiencing an overdose.
- Analyze the recognition and appropriate response to effectively address youth mental health crisis related to significant trauma in the rural setting.
- Identify indicators and employ de-escalation techniques to defuse elevated or enhanced behavior in pre-hospital and hospital settings.
- Distinguish between altered mental status caused by mental health conditions or other factors, and apply appropriate treatment strategies, both chemically and non-chemically.
- Explore the existing scientific research on the impact of blue screen use on dopamine levels in youth and young adults.
- Foster professional resilience and self-care practices for all professionals in high stress fields prone to the development of mental health disorders.
- Recognize the importance of engaging patients in collaborative decision-making.
- Describe the significance of patient self-care beyond medication management as a holistic approach to combat mental health challenges.
